Catherine Cortez Masto for Senate may accept contributions from an individual totaling up to \$2,700 per election; \$5,400 per election cycle. Federal PACs may contribute up to \$5,000 per election; \$10,000 per cycle. Federal law prohibits contributions to the campaign from corporations, labor organizations and national banks; from any person contributing another person's funds; from foreign nationals who lack permanent resident status; from federal government contractors.
